EAAT Program

- North American Riding for the Handicapped Association (NARHA) Standards are met and abided by during all lessons
- Lessons are taught by Molly Barnes, a NARHA Registered Instructor with a four-year degree in Mild Disabilities from Indiana Wesleyan University. (resume upon request)
- One-on-one lessons are created with specific goals and objectives for each individual student such as:
 - Sensory integration
 - Stretching tight or spastic muscles
 - Increased range of motion
 - Improved self-confidence
 - Expansion of focus and control
 - Sequencing
 - Improved hand-eye coordination
 - Problem-Solving
 - And more

Session Highlights

- Private lessons
- Focus on IEP goals, if applicable

- Participant does not need a specific diagnosis to participate

Session Fees and Dates



- Each EAAT Program run 8-weeks in duration, consisting of weekly, ½ hour lessons
- Cost is \$280 per session and payment for the entire session is due in full at the first lesson. (check or credit cards are accepted)
- Dates
 - May 10- July 3- *Wednesday and Thursday afternoons and early evenings*
 - July 17-September 10- *TBA*
 - September 27- November 20- *TBA*

What to Wear

- Long pants and boots or shoes with a heel
- Lessons are conducted inside and outside. Please wear appropriate layers and stay away from loose fitting jackets or coats.
- ASTM-SEI certified helmet- helmets are provided for use during the lesson by Natural Valley Ranch, however, if you have one you are welcome to wear it if it is ASTM-SEI certified.

Horse Leaders and Sidewalkers

- Caregivers are required to serve as horse leaders and/or sidewalkers during the lesson, if needed. Training will be provided by the instructor during the first lesson.
- If a caregiver is unavailable or unwilling to sidewalk or lead the horse during the lesson, the rider will not be able to ride and the lesson will not be rescheduled or refunded.
- All participants in a lesson must complete and sign the [Volunteer Application](#).

Cancellation Policy

- If Natural Valley Ranch cancels the lesson, the lesson will be rescheduled (lessons are canceled at the discretion of the instructor and are due to severe weather, horse lameness, and other uncontrollable circumstances)
